COMMENTARY: Searching by legal citation is very easy in ICLR. In our example, Letterstedt v. Broers appeared in the list of suggested search results after we typed 9 App Cas 371 into the Search Case Law field. Clicking on the case will take us directly to a full-text version of the case.

COMMENTARY: In short, when you search by citation in ICLR, you will be directed to a full-text version of the case. If you want to see a list of subject headings, subsequent considerations, and cases citing a decision, simply click on Case Info.

COMMENTARY: Even if you cannot remember a case name or citation, you still might be able to find it by using some of the other fields available to you in Full Search. In our example, we will try searching by catchwords, date, and court level.
